Promoting the Earned Income Tax Credit

One in five eligible tax payers miss out on claiming the [Earned Income Tax Credit](#) each year. Join us in promoting [EITC Awareness](#) this year to help ensure Whatcom County community members know how to claim this important tax credit worth up to \$6,935.

EITC eligibility depends on several factors, including income and family size, but it's easy to find out if you qualify. Use the [EITC Assistant](#) to verify eligibility and estimate the amount of your credit.
