EVICTION MORATORIUM ENDING

With both state and federal moratoriums on evictions set to expire at the end of this month, [an estimated 6.7 - 13.9 million Americans](#), and [over 170,000 Washington residents](#) could be at risk of eviction. With uncertainty around another stimulus package, and the funding for many rental assistance programs coming to a close, the end of the moratorium on evictions could be devastating for Whatcom County renters.
