ADVANCE CHILD TAX CREDIT PAYMENTS

Recent changes to the Child Tax Credit (CTC) will allow families with children to receive advance payments of the credit starting this summer. The IRS will pay half the total credit amount in monthly installments beginning July 15, and the other half can be claimed when filing a 2021 tax return. How it works:

- Eligible families can receive monthly payments of \$300 per child under 6, and \$250 per child age 6-17.
- Payments will be automatic for households who have filed 2019 and/or 2020 taxes, or who have used the Non-Filer tool to claim an Economic Impact Payment.
- Families who have not filed 2019 or 2020 taxes/used the Non-Filer tool should apply by July 15.
- Households who apply after July 15 can still receive advance CTC payments: they will receive larger (but fewer) payments.

Final Extension of

UTILITY MORATORIUM



Washington's utility moratorium has been extended for a final time and is now set to expire on September 30, 2021. The new expiration date has been intentionally aligned with the end of the housing stability bridge in the hope that those struggling with housing payments will have time to prepare and seek assistance before both proclamations expire. Customers with past-due balances are encouraged to call their utility providers as soon as possible to set up a payment or assistance plan, and to learn about programs and resources that can help prevent disconnections.
