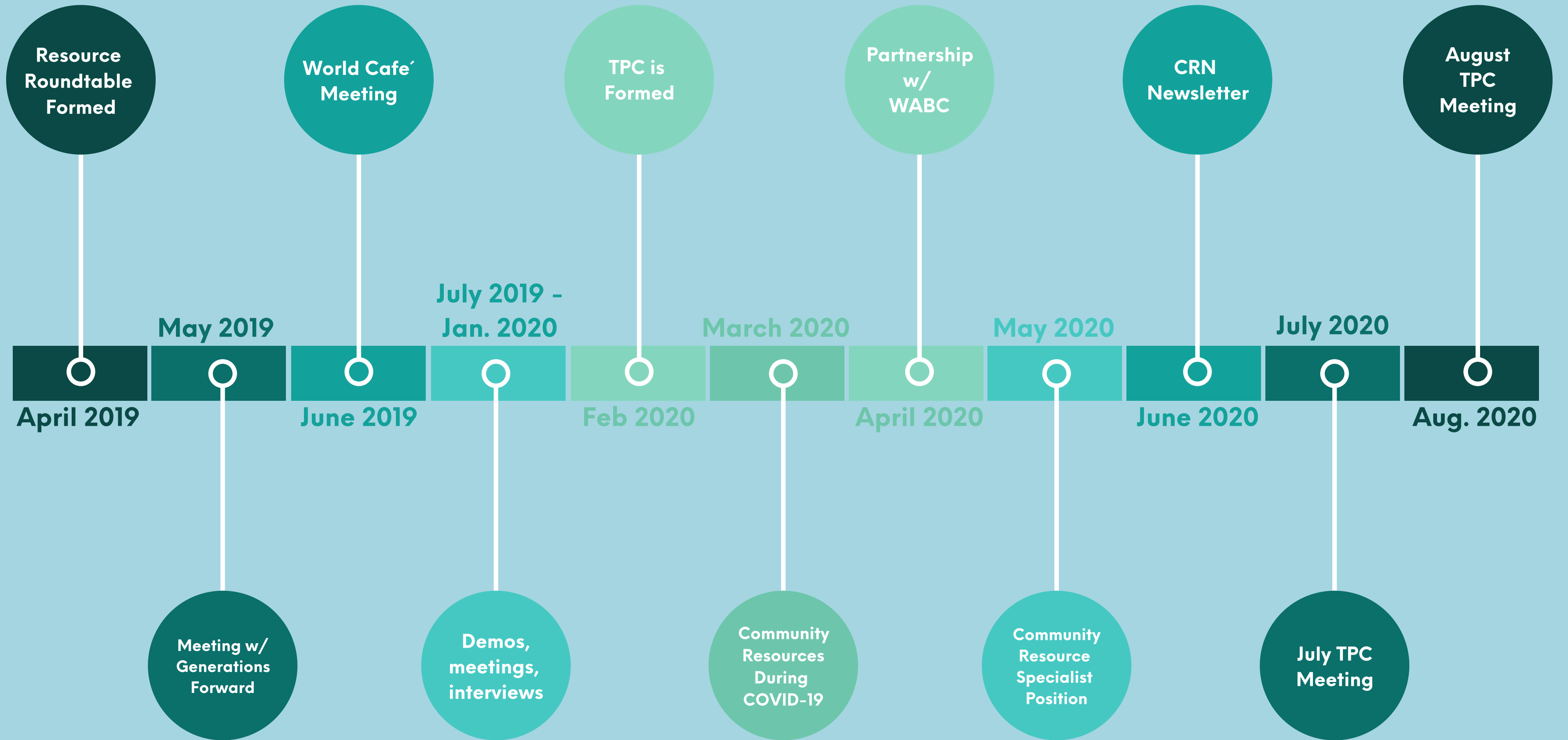
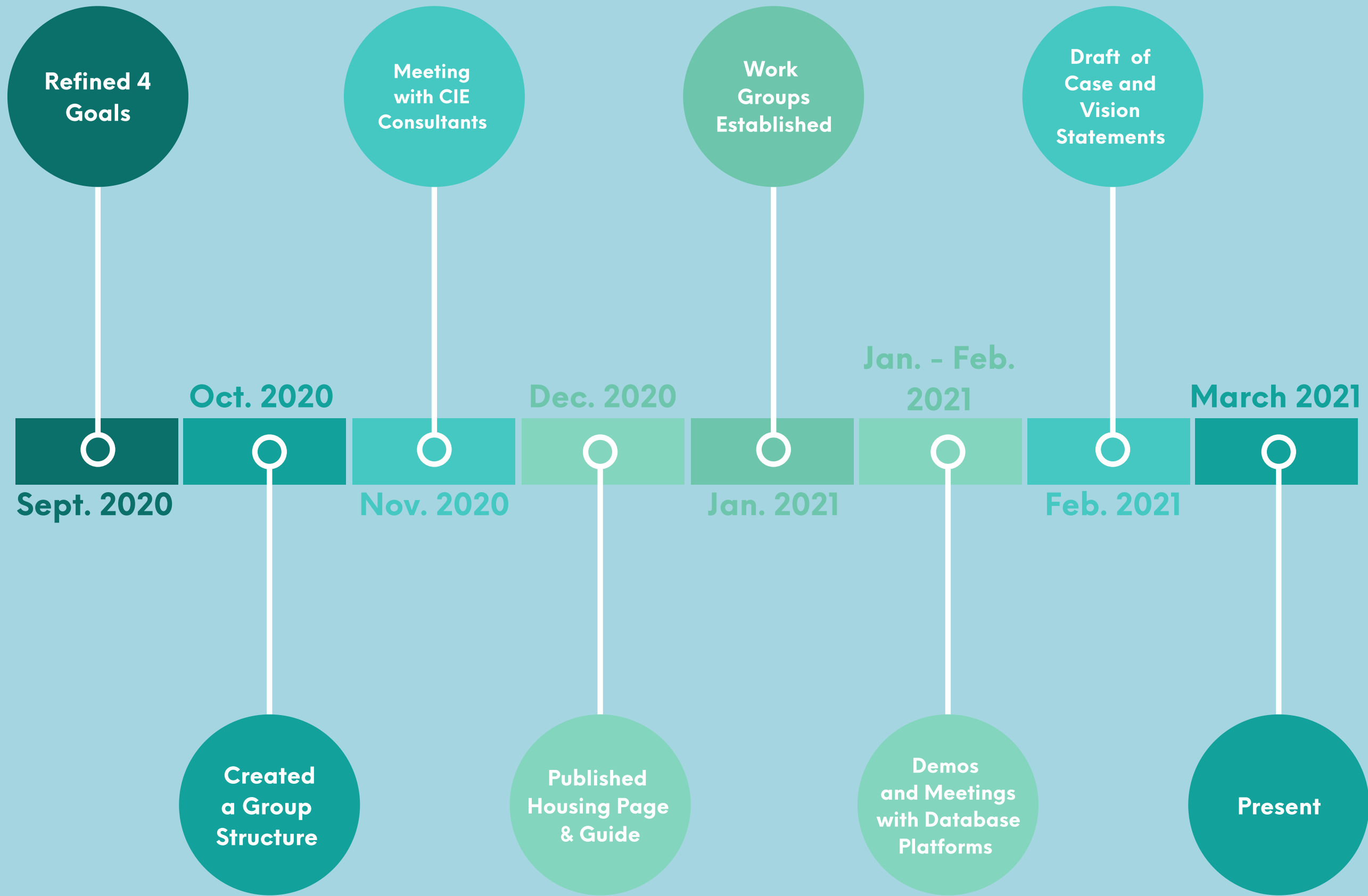

Commitment by the “right leadership” did not develop, capacity from organizations was not there
